CALL TO ORDER & INVOCATION

DISCUSSION & POSSIBLE ACTION

Public Hearing – Northwest Districting

Councilman Charles Carroll MOVED, SECONDED by Councilwoman Sheila Grady to open the public hearing at 6:07 PM. The MOTION CARRIED UNANIMOUSLY.

Mayor Knox read the resolution requesting the general assembly to amend the charter of the City of Northwest to establish council member residency districts.

RESOLUTION REQUESTING THE GENERAL ASSEMBLY TO AMEND THE CHARTER OF THE CITY OF NORTHWEST TO ESTABLISH COUNCIL MEMBERRESIDENCY DISTRICTS

WHEREAS, the City of Northwest is a North Carolina municipal corporation incorporated by the General Assembly on June 28, 1993 by Session Law 1993-222 (House Bill 405);

WHEREAS, the City charter is Section 1 of Session Law 1993-222;

WHEREAS, pursuant to Section 3.2 of the City charter, all of the qualified voters of the entire City elect all of the members of the Council, who may reside anywhere in the City;

WHEREAS, the City wishes to amend Section 3.2 of its charter to change its manner of electingmembers of the Council such that candidates are nominated and elected by all qualified voters of the City but must reside in and represent districts; and

WHEREAS, the City wishes to maintain the Nonpartisan Plurality method of elections as provided in Section 4.1 of its charter; and

WHEREAS, the City advertised and held a public hearing on the proposed charter amendment on August 3, 2021 to hear comments by the public on the proposed change.

NOW THEREFORE, be it resolved by the City Council of the City of Northwest that the City hereby requests that the General Assembly amend the City charter by local act such that:



- 1. The City is divided into three (3) single-member districts and one (1) two-member districtaccording to the attached City Council Residency Districts map, where Districts 1, 2, and 4 are single-member districts and District 3 is a two-member district;
- 2. Members of the Council are nominated and elected by all qualified voters of the City but must reside in and represent districts; and
- 3. The charter amendment is not effective until after the 2021 election and the next election for the City will not be subject to Session Law 2021-56 (Senate Bill 722).
