ASSEMBLY

The Northwest City Council held their special meeting on Monday, March 4, 2019, at 6:30 PM at Brunswick Community College located at 2045 Enterprise Drive, Leland, NC.

Present were James Knox, Mayor; Councilmen: Charles Carroll, Aaron Perkins, Michael Troy, Haywood Miller and Councilwoman Sheila Grady.

CALL TO ORDER & INVOCATION

Mayor Knox called the meeting to order.

Councilman Michael Troy gave the invocation.

PLANNING AND GOALS

1) BASKETBALL COURT

It was the **CONSENSUS** of Council to get a cost on resurfacing the basketball court.

2) FIX DITCH AT CITY HALL

It was the **CONSENSUS** of Council to have Councilman Charles Carroll contact the company that put the driveway pipe in at City Hall and have them correct the ditch so water can flow.

3) PLANNING AND ZONING

With the City of Northwest growing,

Councilman Charles Carroll **MOVED, SECONDED** by Councilwoman Sheila Grady to negotiate with Mike Hargett to provide planning services for the City of Northwest. The **MOTION CARRIED UNANIMOUSLY.**

Councilwoman Sheila Grady **MOVED, SECONDED** by Councilman Michael Troy to move forward with hiring a firm to create and maintain the Webpage and Facebook page. The **MOTION CARRIED UNANIMOUSLY.**

5) PARKING LOT

It was the **CONSENSUS** of Council to procure bids to pave the parking lot at City Hall.

Councilman Aaron Perkins stated that the City may be able to “Piggyback” on the County’s contract.

6) CITY OF NORTHWEST SIGN

It was the **CONSENSUS** of Council to discuss the City of Northwest sign at the March regular meeting.


7) CITY HALL RENOVATE
