ASSEMBLY

The Northwest City Council held their regular meeting on Tuesday, August 23, 2022, at 7:00 PM, at Northwest City Hall, 4889 Vernon Road.

Present: James Knox, Mayor; Councilmen: Charles Carroll, Michael Troy, Sylvester Ballard, and Councilwomen Sheila Grady and Alexis Clemmons

CALL TO ORDER & INVOCATION

Mayor Knox called the meeting to order at 7:00 PM.

Councilman Sylvester Ballard gave the invocation.

CONSENT AGENDA

Councilman Charles Carroll **MOVED**, **SECONDED** by Councilwoman Alexis Clemmons to approve the Consent Agenda as presented. The **MOTION CARRIED UNANIMOUSLY**.

PUBLIC COMMENT

Norris Corbett stated that he though the Police Chief has great ideas and hopes he will be able to implement them.

Foster McKoy stated that he would like the City to have their own Traffic Impact Study done on Northwest Road.

Tina Perkins stated that she would like the City to find grants that would help citizens hook up to utilities.

4. DISCUSSION & ACTION ITEMS

A. BUDGET AMENDMENT – PURCHASE OF GENERATOR

Councilwoman Sheila Grady presented a budget amendment to council for the purchase a generator and installation to run the City of Northwest City Hall/Police during power outages. The budget amendment is in the amount of \$15,000.

Councilman Charles Carroll **MOVED**, **SECONDED** by Councilwoman Alexis Clemmons to approve the budget amendment for the purchase of a generator to include installation in the amount of \$15,000. The **MOTION CARRIED UNANIMOUSLY**.

B. CODE ENFORCEMENT

STILLY'S AVENUE AND BLUE BANKS LOOP ROAD

City Clerk, Donna Strickland, presented the following:

Staff along with Mr. John Ganus (N-Focus) met with Ms. Brenda Brown at her

property located on Stilly's Avenue. The property and structure next to her is in such a state that it can be listed as a dilapidated structure and can fall under the Minimum Housing Code. However, there has been an update in the General Statute that will have to be brought to Council for approval.

City Clerk, Donna Strickland, stated that during discussions of the City's Nuisance and Code Enforcement Ordinances, it was recommended by Mr. Ganus from N-Focus that we adopt all new Ordinances instead of trying to rewrite the existing one, which have not been updated since 1994. If this is agreeable with Council, I can bring the contract to Council at the October meeting.

It was the **CONSENSUS** of Council to have staff bring a contract back to them at the next Council meeting that will provide the cost for N-Focus to rewrite our Ordinances.

• MCKOY PROPERTY LOCATED ON BLUE BANKS LOOP ROAD

On August 10th the camper trailer that Mr. Leon Graham was staying in caught fire and burnt. Staff has sent an email to Mrs. NeCall Wilson notifying her of the fire. Staff will continue to work with her and her father to clean up the property.
